The club executive along with members encourage responsible consumption to member and their guests. The bar manager and staff will promote and enforce responsible consumption of alcohol. There is signage behind the bar reinforcing the message

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

The club has it's own alcohol policy which members are aware of (attached). The bar staff receive training through "servewise" and ongoing training from the bar manager using the CCC education books.along with the "toolkit". Staff are also reminded of their requirements under the act

Free jugged iced water and glasses in prime location at the bar and is freely available. Signs advertising the free water and the consumption of the water will be encouraged by bar staff..

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All bar staff complete and pass the "serve wise" online training prior to starting any bar duties. The bar manager will complete regular on site training with bar staff using the "clubs toolkit" folder is kept on site and all bar staff can regularly preference folder.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The volume of the music played through the clubs sound system can be influenced by the bar staff. The doors facing the road are shut by 10:00pm and all music off turned off by 11:00pm.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

There have been no issues with behaviour or vandalism to date from the issue of the club licence. The club operates as family friendly club bar for members and guests. No nuisance behaviour or vandalism will be tolerated by members of bar staff.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The New Brighton Mall is approximately 2 km's north of the club which has one bar, one working men's club and several restaurants. There would be no increase in alcohol related problems in the area due to this club licence

Beach and sand dunes surround most of the club so there will be no effect. Residential property's across a car park and road would also be unaffected and plans are in place along with Regular communication with residents to ensure there is no impact on residents.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

Privacy Statement

Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

14. Important to note — Renewal with Variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application. More information about statutory timelines can be found at ccc.govt.nz/alcohol
