We have 2 water stations - 1 at entrance at cafe & 2nd in fridge we have water bottled filled with fresh water.

A host responsibility policy is followed; age identification is strictly checked & service is refused to intoxicated or underage persons. A certified duty is on duty at all times when alcohol is sold

Savoire Cafe & Wine Bar operated with in commercial mall environment with low background noise & music. Noise level are expected minimal.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Current level of nuisances & vandalized associated with the premises are very low. The premises operated as a cafe & wine bar within merivale mall commercial area & does not generate disorderly behavior.

Renewal of an existing license & no significant changes to the operation are proposed, the granting of this license renewal will not contribute to an increase in alcohol - related problems in area.

Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
