Staff are trained to organise transport on request by customers within a reasonable timeframe. Transport options can be with a taxi company or dial-a driver service, offer discounted taxi fares or a courtesy van or drop off service. There is a telephone easily accessible to customers that they can call a taxi, or a friend or family member to pick them up as well. Clear signage is available to customers on the transport options.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Be familiar with the intoxication assessment tool. Observations to undertake accordingly. Train the staff to identify those customers. Then limit or avoid selling any more alcoholic drinks to those customers. Suggest alternative options such as low alcoholic drinks, water or advise them to have some food. Host responsibility is attached.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Display the legal drinking age signage. Only accept the legally recognised evidence of age. Avoid selling any alcohol if there is any doubt of the age or the ID provided.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Water jugs available, customers can easily get them and 'free water' signage is up in there.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Staff training includes regular discussions on how to comply with the law and how to respond when a situation arises. We get them familiar with the licence conditions. We train them on how to check the intoxication stages, age identification, how to slow down or stop the service in certain situations. Also the staff are aware of how to support customers if they need any help with transport.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Noise level is very low and we only play soft music inside the restaurant.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have not noticed any level of nuisance or vandalism so far at our restaurant.
If this happens in the future, we will look for the cause and take appropriate actions.

There are so many licensed premises nearby. Such as Robies, Lone Star, Irish Bar etc

Most of them are licensed restaurants and bars in the area. We do not believe a granting of this licence to us would impact any of the neighbouring land use.

 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
