The applicant adheres to the attached Host Responsibility Policy. Appropriate signage is displayed. The manager will take control of any situation that may lead to a breach in the provisions of the Act. Evidence of Age documents are requested from any person looking to be under the age of 25.

The applicant offers free tap water as a matter of course to all patrons. Water jugs are available on request and there is a plumbed chilled water station at the main bar counter for all to use.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Training given by trained professionals for NZQA unit standards 4646 and 16705 for all duty managers. Manager also ensures that all staff will be trained in their requirements/responsibilities under the Act. Done on induction of staff and refreshed as required. See attached employment form.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The nature of the business means the potential noise effects are minimal. Should the unexpected occur and a noise complaint received, it would be dealt with initially by the manager on duty.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The nature of the business means the potential nuisance and vandalism effects are minimal. There is no reason to believe the issue of a licence will negatively impact the neighbouring environment amenity and good order.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Located on the corner of Ilam and Creyke Roads, there are no other licenced premises in the near vicinity. The nature of the business means the granting of this licence wouldn't contribute to an increase in alcohol related problems in the area.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Mostly residential but land near the premises is part of the University of Canterbury. As a restaurant, the premises will have little or no impact on neighbouring land use.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).


Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.
