The premises is managed effectively so that patrons don't become intoxicated. Staff are to encourage food, water and other non-alcoholic drinks or low alcoholic drinks for less consumption. Supply of free water.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

There are proper signage in premises to avoid sale to minor & intoxicated person. Proper training given to staff time to time to reduce alcohol abuses.

For patrons water must be freely available at all times and all on-licences have to include a condition stating a place or places on the premises where it will be available to customers be called attractively presented & free of charge. The position of water where they easily find water near alcohol.

Staff will be trained time to time & most of the training will be provided practically and always discuss about host responsibility policy & discuss all appropriate steps with staff regularly. Discuss about minors & intoxicated persons and always store any incident happens with other staff members.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

There is no school & hospital nearby. I don't think there is an noise problem here. Next door is a bar and other side is dairy shop. It's nothing new in this area.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

To control the future levels of nuisance and vandalism we have already installed security cameras all over the premises and it's easily seen on T.V's and we have signs for video surveillance in operation too.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

One side of the premises is the Opawa food mart and the other side is Opawa Bowl & Packs. It is an industrial/commercial area near by & there is quite less residential area, so I don't think any alcohol related harm in this area.

Land nearby the premises is commercial area for business purposes. Most of the premises are like car sales, Caravans specialist, Panel/Panel, petrol station, car servicing, furniture shop etc.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
