Make sure new staff are aware of the host responsibility policy by way of a buddy system with a manual to remind. Trained duty manager on site at all times.

Currently operating as a cafe with some music played indoors - which is minimal and only noticeable if you are sitting within our outdoor boundary.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Hardly any vandalism or any level of nuisance as our next door neighbour is a hostel building which has staff residing/working 24/7. They usually keep an eye out for any abnormal behaviour, which is minimal. Located by a wide intersection, our building is pretty open and visible so it is less of a target as such.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are a few bars and restaurants that sell alcohol on New Regents Street but as we will remain a cafe, focusing more on non-alcoholic drinks and cafe food, it isn't likely to contribute to the alcohol related problems in the area.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.
