Provide test results of 8 conforming site welds for each category applied for, including peel /decohesion test results, which were performed under the supervision of a Council Approved Welder and which comply with the category of the application and have been undertaken by the applicant within the past 12 months. Also include details of the welding machine used. The conforming welding results submitted with the application must include couplers, tapping bands, tees and reducers of various sizes. Note that upon successful assessment the applicant will be approved up to the maximum size of test results submitted.
