		When there are lots of people around, and it is a warm summer's day, I can see the need for the P60 time limit at this carpark, for some and possibly all the parking spaces. A sign		
		would need to be displayed as to where other parking is available. And with safety in numbers, the other carparks would be acceptable.		
		But you can be up on the Port Hills at times when there is hardly anyone around. This carpark is the most visible along the Summit Road and as such I would consider it the safest, both for an individual and the parked vehicle. At such times, this is where I would wish to park and sometimes I might be the only person parking there, or just a few cars. It is also		
		the only carpark in close proximity to toilets - often necessary before and after exercise. On a wet day, it will be good to change out of wet clothes before driving away. Being able		
		to finish exercising, get dry clothes out of the car and change in the toilets, is only possible using this carpark.		
		If you were to make a P60 at all times, it is likely that you will restrict some people from being able to enjoy the Port Hills at times when this carpark has very few cars. Please don't		
		do that. And hopefully begin with the minimum time that any control is needed.		
		If you begin with a greater time period, it is unlikely to be reduced, even if it is not needed, whereas extending the time period will happen if it is needed. It may be found that on really busy times, a shorter park time for some parks is required. Observation data is required to determine when a control on parking might be required.

		No one is going to take any notice of the parking restrictions when it's obvious during the weekend, when the parks are full, that there will be no one to enforce them.		
		Seriously? Is that the extent of your imagination to solve the problem? It's a waste of everyone's time.		
		We are up there almost every weekend, and for anyone who does visit there the solution is obvious.		
		The first "long term" park to the south needs to have car parks painted on them, perpendicular to the road, Many times people park parallel to the road and significantly reduce the number of vehicles that can park there. Some organizing of the parking there would make a great difference to the amount of vehicles that can park there.		
		A big "More parking around the corner" sign at the sotk pointing in the direction of the park might tell new visitors that it exists. New people don't drive around the corner, they drive up, see its full and drive on.		
		The second, further away one was recently just graded, and has created an ideal place for hoons to do spinouts. I am sure they are happy with the work you have done.		
		However it's just degrading the surface, sending rocks onto the road that the cyclists have to try and avoid, scouring into channels from the water runoff, and stopping people from wanting to park there.		
		If you can't seal it then some well placed rocks, like on other parks in the hills, would stop the activity and add a degree of structure to the parks.		
		The Mtn bikes come off the flying nun there now just before the car park and they need a way to stop spraying the road with stones as well.

		Many cars park on the verges up the hill towards the long term parks. This is OK but the potential is there for accidents as vehicles, cyclists and walkers all travel the same narrow piece of road together. ### Submission on Proposed parking changes at Sign of the Kiwi

#### 1. INTRODUCTION

- 1.1 The Spreydon-Cashmere Community Board ("the Board") appreciates the opportunity to submit on the Proposed parking changes at Sign of the Kiwi.
- 1.2 The Board would like to speak to its submission.

#### 2. GENERAL

- 2.1 The Board is aware that there is a high demand for short stay parking in the carpark beside the Sign of the Kiwi.
- 2.2 The Board recognises that car parking in the vicinity of the Sign of the Kiwi needs to cater to the requirements of all visitors but particularly for those with a disability. It may be that the disabled and older persons communities have a better idea as to where the accessible car park should be placed and the board would be supportive if a change was sought. The Board is simply concerned to ensure that a park with a view of Christchurch is available for people with a disability.
- 2.3 The Board is satisfied that the proposed changes to the existing carpark at the Sign of the Kiwi to restrict 10 existing carparks to 60 minute parking, to convert one existing carpark to a mobility park and to signpost designated motorcycle parking will better provide for the requirements of visitors.

#### 3. SUBMISSION

The Board therefore **supports** the proposed parking changes at Sign of the Kiwi as set out in the consultation documents or incorporating a change to location of the mobility park as sought by the disabled and older persons communities.
