However, I think that it would be confusing to have varied time limits, and that it would be better to set all parking restrictions at the ferry terminal at a 4-6 hour maximum. Whilst 3 hours may often be sufficient for a trip to Lyttelton, it is insufficient time to use the connecting bus into the city and to return after errands or meetings. The ferry is frequented by a number of older residents, who may struggle up the steps to the Stoddard Point car park, especially with bags. I also think that one disabled car park in this area is sufficient. Over the years, I have never seen both used, and very rarely one.
