A deeply incised arc on the surface symbolises the orbit path of the race. Speed is indicated by the red jewel symbol of the mechanical principle of jet propulsion – the venture. Dividers rising from the globe to the cup itself symbolically span the portion of the orbit encompassed by the speed race. The triangulation signifies the measured precision in the science of navigation, surveying, and engineering, which are epitomised in the nature of the contest.
