

NZTA Funding - LCLR Targeted Fund (2024-27)

1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 The purpose of this memo is to advise elected members of additional funding that has been received from NZTA as a targeted fund under their Low -Cost-Low-Risk (LCLR) activity class.
- 1.2 The information in this memo is not confidential and can be made public.

Background

- 2.1 Through the course of the FY26 Annual Plan information sessions and discussions about NZTA funding, it was identified that there would likely be future opportunities for additional funding through the LCLR activity class.
- 2.2 In late 2024 council was advised by NZTA that there was opportunity to apply for additional funding from NZTA as part of a targeted fund under their LCLR activity class. This means the value of any individual project/package must be under \$2M. The NZTA funding rate is 51% on eligible items.
- 2.3 The funding is within the current National Land Transport Fund (NLTF) period and therefore works are required to be completed by 30 June 2027.
- 2.4 Applications for the targeted fund had to be lodged by 25 February 2025 and all applications had to be for new work.
- 2.5 Given the tight timeframes for submission, staff undertook a session to identify possible works from within the wider renewals programme.
- 2.6 This assessment formed the basis of the application. Staff also confirmed whether there was potential to find the required local share funding for the project from the 2024/27 Long Term Plan.
- 2.7 NZTA utilised their strategic prioritisation model to assess projects against:
 - 2.7.1 Resilience improvements, including drainage work
 - 2.7.2 Economic growth and productivity



- 2.7.3 Reducing whole-of-life costs
- 2.8 The successful projects are detailed in Section 3 and the list of projects that were applied for and not successful are listed in Section 4.

3. Funded Projects

- 3.1 The following projects were submitted and all were successful in being approved for funding:
 - 3.1.1 Mitigation Of Cluster Flooding Sumner
 - 3.1.2 Mitigation Of Cluster Flooding New Brighton
 - 3.1.3 Mitigation Of Cluster Flooding Edgeware
 - 3.1.4 New Retaining Wall Dyers Pass Road (no 572)
- 3.2 The total amount of additional funding from NZTA is \$2.79m and the corresponding Council share is estimated at \$2.68m

New Retaining Wall – Dyers Pass Road (no 572)

- 3.3 The council share (49%) of the Dyers Pass Road retaining wall has been drawn from the Transport Structures Programme under staff delegations.
- 3.4 The need for this wall was identified following a slip in February 2025.
- 3.5 The slip has undermined a guardrail and put the road at risk unless a new wall is constructed.

Mitigation Of Cluster Flooding Projects

- 3.6 The council share (49%) of the flooding project has been drawn from the Street Renewals Programme under staff delegations. The street renewals programme is the most closely aligned to the works proposed.
- 3.7 The flooding projects were put forward as the top priorities based on records of information from residents, businesses, roading maintenance teams, and the known impacts of high rainfall.
- 3.8 The Sumner and Edgeware areas were prioritised based on the commercial nature of the proposed area for treatment, in line with the economic growth and productivity criteria outlined by NZTA.
- 3.9 The New Brighton area was included based on the size of the treatment area and wider community impact.

Moving Forward

- 3.10 Once the projects teams have more information they will liaise with the relevant Community Boards.
- 3.11 The final treatment solution will inform the need for public consultation.
- 3.12 Transport teams are working with the Three Waters teams, to ensure a unified approach to surface flooding and other planned works. This was highlighted at the Surface Flooding Reduction Programme Workshop on 10 June 2025.
