The submission points of Teewah Holdings Limited, and Wigram Lodge (2001) Limited and Elizabeth and John Harris, were accidentally left out of the summary of submissions made public on 30 June 2023. On the submission of Tobias Meyer, the summarised submission points did not accurately reflect the full submission. All of this has now been corrected and included in a second addendum to the original summary of submissions, which people can make a further submission on from today.

It is not an opportunity to make a new submission on matters not raised in these submissions or beyond those points included in the addendum. If you make a further submission, you must serve a copy of it on the original submitter within 5 working days of you providing the further submission to the Council.

The following persons may make a further submission on the proposal:

- The local authority, Christchurch City Council, may make a submission
- Any person representing a relevant aspect of the public interest
- Any person that has an interest in the proposed policy statement or plan greater than the interest that the general public has
